Edward Donelan is a lawyer and an internationally known expert in regulatory governance, regulatory reform, and legal reforms. He is qualified as a lawyer in Ireland and the United Kingdom. Working in and for the OECD for 17 years, he carried out international comparative assessments of regulatory governance capacities in 30 countries in Eastern Europe, the Balkans, the Caucasus, the Middle East and North Africa, which were published by the OECD http://www.oecd-ilibrary.org/fr/governance/documents-sigma_22204261

These assessments covered a range of important issues, including Public Administration Reform, Policymaking, Legislative Drafting and Regulatory Management. Mr. Donelan has worked on regulatory governance issues in 40 countries.

He has also drafted legislation in a wide range of fields, including Intellectual Property, Financial Services, Health and Safety, Electricity, Telecoms, deregulation and re-regulation of Electricity and Telecommunications, as well as a wide range of regulations to give effect to European Commission Directives. As Director of Statute Law Revision in Ireland, he managed a team of lawyers to review all legislation in force in Ireland from 1215 to 1922. As part of that work he advised the Government and Parliament to repeal over 1,000 spent and unused laws. He also given advice on other reforms to make statute law in Ireland more accessible and coherent.

Fluent in English, French and Spanish, he has a reputation for gaining client confidence quickly by proposing customized solutions for regulatory government reforms in developing and transitional countries. He is an accomplished advocate with experience of politics, television, radio, court work and teaching the theory and practice of law and regulatory governance.

November 1998 to October 2004

Director of Statute Law Revision Unit, Office of Attorney General, Dublin, Ireland, the Unit was established, on his advice, by the Government of Ireland to review all legislation in force dating from 1215 (Magna Carta) to 1922 (Independence from the United Kingdom), to consult on whether the statutes were still of practical utility and, if not, give advice on whether they needed to be repealed or modernised. The Unit also developed a policy to make legislation more accessible by publishing consolidated versions of legislation that had been amended three or more times. The Unit played an influential role in regulatory reforms in Ireland and was instrumental in the development of a policy on Better Regulation.
