Dr. Cordova is an international expert on regulatory reform and good governance issues, advising governments of more than 50 developed or in-transition countries. - Dr. Cordova is the primary developer of the RegulatoryResultsCalculator (RRC)©, an adapted Standard Cost Model measurement methodology embedded into software that permits reformers to calculate the pre-reform baseline and the monetary outcomes of systematic licenses and permits reforms. The RRC has been deployed in Laos PRD, Kyrgyzstan, Bosnia, Serbia, Montenegro, and Kenya (see IFC Smart Lessons, May 2009).
