**SCOTT JACOBS** is a leading global expert and author with 34 years of experience in regulatory reform, regulatory impact assessment (RIA), and good business environments. He is Managing Director of Jacobs, Cordova & Associates, an international corporation specializing in regulatory reform solutions. He organized and directed the OECD Program on Regulatory Reform from 1991-2001, where he wrote many of the recommended RIA and other good regulatory practices now used as worldwide benchmarks. He has worked with over 100 industrialized and developing countries in Europe, Asia, Africa, and the Americas in designing and implementing a wide range of regulatory reforms. A pioneer in the RIA field, he has worked on designing and implementing RIA systems in around 50 developed and developing countries. He has authored numerous articles on RIA and 22 books on regulatory reform. His latest publication is “RIA: Towards a Simpler and Practical Approach”, Chapter 6 in *Handbook of Regulatory Impact Assessment*, Edited by Claire A. Dunlop and Claudio M. Radaelli, Edward Edgar, 2016. He was a peer reviewer for the World Bank report, Ladegaard, Peter Farup; Lundkvist, Petter; Kamkhaji, Jonathan Camillo. 2018. *Giving Sisyphus a helping hand: pathways for sustainable RIA systems in developing countries*. He carried out comparative research on RIA methods in 21 APEC economies, published by APEC as 2016 FINAL REPORT ON GOOD REGULATORY PRACTICES IN APEC ECONOMIES.

**DR. CESAR CORDOVA** is an international expert on regulatory reform and good governance issues who has advised governments of more than 30 developed or in-transition countries. Since joining Jacobs, Cordova & Associates as director in January 2004, he has worked with the governments of Albania, Bangladesh, Belgium, Bhutan, Bosnia and Herzegovina, Canada, El Salvador, France, Germany, India, Italy, Jordan, Kenya, Kosovo, Lao PDR, Macedonia, Mexico, Moldova, Nepal, Nicaragua, Nigeria, Paraguay, Peru, Rwanda, Serbia, South Africa, Syria, Turkey, Tunisia, Uzbekistan, United Kingdom, and Vietnam on RIA and regulatory reform aspects. In parallel, he has worked with the World Bank, the Inter-American Development Bank, the Asian Development Bank

and the International Labour Organization on horizontal issues concerning the setting up of an institutional architecture to drive systemic reforms, the assessment of regulatory burdens and policies through RIA, the improvement of regulatory compliance through effective inspection system, and the strengthening the governance of sectoral autonomous regulators. As deputy head of the OECD Program on Regulatory Reform until 2003, he worked with 30 OECD countries in cutting-edge regulatory design. He directed the OECD country review program – coordinating programs between the OECD and APEC and South East European countries. Prior to joining the OECD, he was the General Director for the Economic Deregulation Unit within the Mexican government and was a negotiator of the North American Free Trade Associations (NAFTA). He has authored many articles and books on regulatory reform and good governance in OECD countries, Latin America, and South East Europe. Dr. Cordova has a French and Mexican nationality.

**DR. GIACOMO LUCHETTA** is a Regulatory Analyst with both hands-on and scholar experience in the area of Better Regulation, including a particular focus on Regulatory Impact Analysis and the Standard Cost Model. He works for *Economisti Associati*, where he is a consultant to European and international institutions on these topics. Before joining *Economisti Associati*, he has been a researcher at the Regulatory Policy Unit of the Centre for European Policy Studies, under the supervision of Prof. Andrea Renda. He has carried out several Impact Assessment studies and more than 50 SCM quantifications for various Directorates General of the European Commission, and has been involved in the background study for the forthcoming revision of the EU Impact Assessment Guidelines. His teaching experience on these topics includes the delivery of training on Impact Assessment to European Commission officials and government functionaries in developing countries, and academic courses on EU policymaking. He has published on leading peer-reviewed journals on the topic of Impact Assessment and ex post policy evaluation in the EU.
