eir is the largest telecommunications operator in Ireland and the Director is a member of the senior management team reporting to the CEO.

Key Achievements and responsibilities:

- Leading the engagement with the regulator and government on all public affairs and compliance issues. Eir is a heavily regulated entity and regulation impacts both retail and wholesale aspects of eir's business
- Leading the engagement on the exit of eir from the National Broadband Plan and liaising with the Irish government on the continued support of the NBP. Supporting and attending eir's presentations to parliamentary committees on policy and broadband issues

#### Market Reviews Implementation
